

## **ZAHRA (S.A) ISLAMIC SCHOOL (ZIS)**

### **STUDENT DISCIPLINE POLICY**

For any unacceptable action and/or violation of any school rule or regulation, students will be disciplined according to the statement in this policy. Misconduct and violation of any school rule or regulation will result in consequences as mentioned below:

#### **LEVEL I INFRACTIONS**

1. Disruptive behavior on the school premises or in class
2. Coming to class or prayer late or unprepared
3. Improper behavior during class or prayers
4. Inappropriate attire
5. Chewing gum during school activities
6. Deliberate avoidance of prayers
7. Bringing unauthorized or inappropriate material to school such as music players, magazines, personal diaries (unauthorized items will be confiscated)
8. Bullying of any kinds towards anyone
9. Using devices in class for tasks not related to the lesson

**CONSEQUENCES: Warning, and/or loss of a grade point**

#### **LEVEL II INFRACTIONS**

1. Committing Level I infractions 3 or more times
2. Destruction or defacing of school property
3. Lying
4. Stealing or hiding anyone's property
5. Disrespect or defiance of faculty and staff
6. Fighting with or hurting anyone
7. Using obscenity or abusive language
8. Indulging and pursuing acts of romanticism including flirting, courting and note passing.
9. Compromising the integrity of the school by undressing/dressing in the vicinity of the school.
10. Leaving the school premises without permission
11. Using the internet to access inappropriate and immoral websites
12. Reading of inappropriate literature
13. Skipping/cutting classes
14. Possession, use, sale, or distribution of cigarettes

**CONSEQUENCES: Loss of grade point – Meeting with parents**

### **LEVEL III INFRACTIONS**

1. Committing Level II infractions 3 or more times
2. Possession, use, sale, or distribution of alcohol, narcotics, or any illegal substance
3. Possession of weapons or objects that can cause bodily harm
4. Committing or being accessory to a violent or harmful act, such as arson, that puts the lives of students and those who occupy the school building at danger.

### **CONSEQUENCES: EXPULSION**

In order to uphold the school's commitment to the prevention of tobacco use, **smoking by faculty members, staff members, parents, and students is prohibited in the school building at all times.**

**The Administration reserves the right to expel any students at any time, should a major infraction occur or if he or she continuously commits minor infractions.**

### **PRAYERS**

It is mandatory that all students participate in the prayer sessions that are held at School. Zahra (S.A) Islamic School reserves the right to question any discrepancies including frequent or consistent absences from prayers.

**THE DECISION OF THE PRINCIPAL/MANAGER WILL BE FINAL IN ALL MATTERS OF THE SCHOOL.**
